

# **New Anytime League**



**NEW** indoor target league, perfect for the person whose schedule won't allow them to shoot our regular set time target leagues.

Shoot anytime, any day, Monday through Sunday. (Score cards are picked up on Mondays)

Shoot with someone or by yourself (We trust you!)

Shooting 5 arrows, shoot a single spot or a 5 spot target

Non-members can shoot, but they need to shoot with a member.

Do you want to shoot in a league this winter, but your schedule does not fit with the Flint Bowmen league schedule? Maybe you don't want to shoot 20 yards because you are more comfortable shooting 15 yards. Well, we have the league for you, the Anytime League is perfect for you.

You can shoot anytime you want and whatever distance you want to shoot. Most of us shoot from 20 yards, but if you are new to archery, you are welcome to shoot from 15 or 10 yards. This is great for the entire family, so bring the wife and kids with you. This is an introductory league for someone who has never shot an indoor league or for anyone whose schedule is inconsistent.

This is an 8-week league, but we have 12 weeks to shoot it. That means if you miss a week, don't worry, shoot the next week. If you want to shoot twice in one week, you can do that too.

We will be shooting the blue targets. That means you will be shooting 5 arrows each round. You will shoot 60 arrows for the game each week. If this is too much for you at one time, you can shoot 30 arrows one day, thirty arrows on the next day or later that week to complete the game. This is the most user-friendly league you will ever find.

The cost of the league is \$7 for adult members, \$3 for youth members and \$5 for senior members. Nonmembers can shoot this league, but they will need to be with a member to do this.

This is my 3<sup>rd</sup> year doing this league. It has been a smaller league but shooting this league kept me shooting in the winter and has been fun for those who have shot it.

Please remember to take care of your targets when you are done shooting the inside range. We do this because it makes the shooting wall last longer. It is important we move targets around so we don't shoot the same spots all the time. If the targets are kept in the same spot, it will create a hole, and that is not good.

If you find it hard to pull your arrow out of the new wall, use the white tubes on the red bow holders to lubricate the tips of your arrows and you will find it much easier to pull the arrow out of the bales.


